ACADEMIC PROGRAM-BUILDING

The Mexican Migration Field Research and Training Program: Founder and Director

Professor Cornelius began planning the Mexican Migration Field Research and Training Program (MMFRP) in 2001. After three years of Academic Senate/CEP reviews and revisions, the program received final approval in Spring 2004 and went into operation in the 2004-05 academic year. Since retirement in 2009 Professor Cornelius has continued to serve as faculty director of the MMFRP, taking UCSD students into the field (rural Mexico and California) each year. He has also been the program's sole fund-raiser since 2009, obtaining extramural and UC grants totaling \$466,109 for direct program support, with another \$737,122 grant pending.

Now in its eleventh academic year, the MMFRP seeks to train a new generation of students to become proficient field researchers in international migration studies and to prepare themselves for careers requiring a professional specialization in immigration. An additional goal each year is to create a new, individual-level database on Mexican migration that can be used to address key issues of public policy on both sides of the border. The MMFRP has established long-term field research sites in the Mexican states of Oaxaca, Yucatán, and Jalisco, each of which is re-studied every three years. The fieldwork sites in rural Mexico and the United States (California, Oklahoma) vary from year to year, as do the program's substantive foci. Each year since 2009 the program has devoted major attention to the health consequences of migration to the United States for migrants and their relatives left behind, pursuant to the program's goal of training students for medical and public health careers.

Each year the MMFRP trains approximately 30 undergraduates and graduate students from UCSD, other UC campuses, and Mexican partner universities to collect survey and qualitative data in rural Mexican migrant-sending and U.S. immigrant-receiving communities. Students are also trained to analyze and write up the field data that they collect for publication. Students are admitted competitively from majors in all disciplines, including majors in bio-medical sciences, social sciences, and humanities.

All students who participate in the MMFRP become published authors at the end of the threequarter sequence of MMFRP courses. They co-author either articles submitted to peer-reviewed scholarly journals or chapters in a book based on the year's fieldwork. To date, eight edited volumes of MMFRP student-authored papers and more than fifteen student-authored journal articles have been published, in influential journals like the *Journal of Immigrant and Minority Health.* Two of the books co-authored by MMFRP students have won the *Choice* "Outstanding Academic Book" award and all books in the MMFRP series have garnered highly positive reviews in major, interdisciplinary journals like the *Latin American Research Review, Contemporary Sociology,* and the *Journal of Ethnic and Migration Studies*. When established at UCSD nine years ago the MMFRP was unique in the United States, and it continues to be the only undergraduate/graduate training program of its type. After only one year of operation the MMFRP won national recognition in *The Chronicle of Higher Education*, which profiled it as an innovative approach to creating primary research opportunities for undergraduates at a major research university (Eric Wills, "Crossing Boundaries: San Diego Program Illustrates the Growing Use of Undergraduate Researchers," *The Chronicle of Higher Education*, May 20, 2005).

The MMFRP is one of UCSD's premier academic enrichment programs for underrepresented students. Approximately nine out of ten students admitted to the program belong to underrepresented groups, especially Latinos, whose Spanish language skills and cultural competence are rewarded through participation in the MMFRP (and are, in turn, an integral component of the program's success as a vehicle for primary research).

UCSD students who participate in the MMFRP achieve remarkable (100%) success in applications to graduate and professional schools, including Ph.D. programs at top research universities as well as top-tier law and medical schools. Other MMFRP graduates have won leadership positions in public education, non-governmental organizations, and private businesses. They attribute their access largely to the research skills developed through participation in MMFRP and to the publication of their research results.
